

Hand Crimper and Hand Tool Rental

Listed within the memo are the proper uses for each hand tool we offer. Some hand tools will be sent along with the rental of the electric seamer while others will need to be rented separately and/or purchased if offered.

<u>Battenlok[®] HS</u> requires the use of a **Hand Crimper**. The **Hand Crimper** is Rented separately from the electric seamer and is used at all clip locations prior to Running the electric seamer on the roof system.

The **Push Tool** is used for seaming the *Battenlok*[®] panel side laps in vertical applications and can not be used with the Battenlok[®] HS panel.

<u>Superlok</u>[®] requires the use of a **Hand Crimper** and a **Phase I – Phase II Hand Tool**. The **Hand Crimper** is rented separately from the electric seamer and is used at all clip locations prior to running the electric seamer on the roof system. The **Phase I – Phase II** hand tool is shipped along with the electric seamer and is used to prepare the panel for the use of the electric seamer. A **Phase I – Phase II** hand tool is not available for rent separately.

<u>Double-lok</u>[®] requires the use of a **Phase I – Phase II Hand Tool** and is shipped along with the electric seamer and is used to prepare the panel for use of the electric seamer er. If the electric seamer is not available before the panels are to be installed, a **Phase I Hand Tool** may be rented to temporarily secure the panel until the electric seamer can be shipped. A **Phase I – Phase II Hand Tool** is not available for rent separately.

<u>Insulated Battenlok[®] (IBL)</u> does not offer a hand tool for rent. If a customer prefers to have a hand tool for installation then **Rib Locker (HW-1269)** must be purchased separately.

<u>CFR</u> requires the following tools: **Hand Seamer (HW-1269); Seam Clamps** (9910XNC). These parts should be ordered and shipped with the CFR panels. They are not available for rent. For Credit Use Only Open Terms / Net on Receipt C.O.D. / Deposit Required

RENTAL TERMS AND CONDITIONS

- 1. Parties; Renting. All references to MBCI refer to Cornerstone Building Brands (hereinafter "MBCI" or "MBCI"). MBCI and Customer (named on the face hereof) may sometimes collectively be referred to herein as the "parties." MBCI rents to Customer and Customer hires from MBCI the tools or equipment (the "Equipment") described on the face hereof.
- 2. Binding Effect. The following terms and conditions (the "Terms and Conditions") shall apply to any and all equipment lease between MBCI and the Customer and shall not be waived, modified or amended without the express written consent of the MBCI's President or Executive Vice-President. Terms contained within any other purchase order, service order or other agreement issued by Customer conflicting with these Terms and Conditions shall be of no force and effect. All leases by MBCI of any nature to Customer shall be made under the provisions of this Agreement. Any documents that Customer may use for its convenience including, but not limited to, purchase order, services order or other agreement forms, shall be deemed to be for the administrative convenience of Customer rolly, and this Agreement as well as the terms and conditions as hall be deemed to be for the administrative convenience of Customer shall be administrative convenience on the agreement issued by BCI's invoices and bills of lading shall supersede and take precedence over any of Customer's terms and conditions which may be contained on any such forms. Further, should MBCI as tupon this Agreement without first obtaining Customer's terms and conditions to the exclusion of any contrary terms and conditions proposed by Customer. All orders or leases are subject to approval and acceptance by MBCI. CUSTOMER SPECIFICALLY AUTHORIZES MBCI TO FILL IN ANY BLANKS IN ORDER TO REFLECT THE PARTIES' AGREEMENT AND CORRECT ANY APPARENT ERRORS. CUSTOMER ACKNOWLEDGES RECEIPT OF A TRUE COPY OF THE RENTAL AGREEMENT WITH BLANKS FILLED IN TO CU
- 3. Payment. Payments due MBCI under the terms of this lease and any other money due MBCI by Customer shall be paid to MBCI in U.S. dollars at its Houston, Harris County, Texas office. Unless otherwise agreed in advance and in writing by MBCI's Credit Department, rental payment for the Equipment under this Agreement shall be due and payable in full, without set off or offset for any reason, upon receipt of MBCI's invoice. MBCI reserves the right to change the terms of payment as stated herein at any time for any reason at the sole discretion of MBCI without prior written notice to Customer. Unless specifically enumerated on the face hereof, the rental price does not include any taxes (including excise, privilege, occupation, use, sales, etc.; Federal, State or local) or costs of shipment. All Equipment leased H-reunder are leased F.O.B. MBCI's paints.
- 4. Term of Rental; Termination. Rental charges commence when the equipment arrives/delivers and cease when the Equipment is returned to MBCI's location in as good condition as when received, ordinary wear and tear excepted, and Customer shall pay for repairs or replacements of all parts damaged by misuse or for all damage done; and Customer shall remain liable for rental hereunder until repairs or replacements to the unit have been completed. Customer may terminate this Rental Agreement at any time by notifying MBCI when Customer wishes to return the Equipment, with such termination effective upon the return of the Equipment to MBCI, at Customer's sole expense. MBCI may terminate this Rental Agreement for any reason whatsoever (including for convenience) upon twenty-four-(24) hours notice in writing to Customer shall nevertheless remain liable for rall is obligations hereunder through termination and for all sums then due and unpaid, plus a reasonable amount for altorney's fees and such expenses as may be expended in the repossession of the Equipment. The remedies provided herein in favor of MBCI shall not be deemed exclusive, but shall be cumulative and in addition to whatever other remedies MBCI may have at law or in equity. Customer's indemnification, hold harmless and repair obligations will survive termination of this Rental Agreement.
- 5. <u>Return Of Equipment; Holding Over</u>. Upon the expiration or termination of the Rental Agreement, Customer shall, unless otherwise directed in writing by MBCI, deliver the Equipment to MBCI at the address for MBCI from which the Equipment tass sent at the commencement of the rental. Any expenses relating to the return of the Equipment to MBCI shall be borne by Customer, including, without limitation, any costs incurred by MBCI in connection with removal of the Equipment. If the Customer stalls continue unchanged and the Customer shall continue to pay the agreed to rental rate(s) on the face hereof until by MBCI in addition to the forego-ing, MBCI may also elect to charge Customer for the declared value of the Equipment indicated on the face hereof. - 6. <u>Additional Freight Charges</u>. Customer is responsible to supply the proper ship to address for outbound seaming equipment and for shipping the equipment back to the proper address when finished with the equipment. Delays in receiving equipment and any additional freight charges due to shipping address errors will be the customers' responsibility. Customer is also responsible for providing sufficient and proper lifting equipment and/or man-power to unload the seaming equipment whon arrival and to reload the seaming equipment when returning same. Failure to provide sufficient and proper lifting equipment and/or man-power equipment which may result in additional freight charges, including but not limited to, rescheduling and lift gate charges.
- 7. <u>Absence of Encumbrance or Unauthorized Use</u>. Customer shall not grant any lien or security interest in or otherwise encumber this Rental Agreement or the Equipment, nor permit any other person to use the Equipment without MBCI's prior writ- ten consent. If Customer fails promptly to discharge or remove any such claim, lien, security interest or legal process, MBCI may at its option discharge the same, advancing any amounts necessary therefor. Customer shall promptly reimburse MBCI for all such amounts with interest at the maximum legal rate. Upon request by MBCI, Customer shall immediately execute and deliver to MBCI UCC-1 forms for recording in the proper government offices.
- 8. Costs of Collection. If an invoice becomes past due, is placed in the hands of an attorney for collection, if collected by any legal proceedings, or if this Agreement is relevant to any other dispute between the parties, in addition to any other amounts and damages recovered by MBCI, Customer agrees to pay MBCI any and all attorney's fees and costs incurred in the collection of sums (which includes, without limitation, costs incurred in litigation, copying and mailing expenses, line fees, lost management time, inspection expenses, and expert witnesses expenses in addition to taxable costs incurred in litigation) wed by Customer to MBCI on account of principal, interes or other charges, which attorney's fees shall not be less than thirty percent (30%) of the total amount payable.
- 9. No Sale or Security Interest Intended. This Agreement constitutes a lease of the tools or equipment described on the face hereof and is not a sale or the creation of a security interest in the leased property. MBCI at all times retains sole ownership and title to the leased property, and Customer does not have and will not have, at any time, any right, title or interest in the leased property, except the right to possession and use as provided in this Agreement.
- 10. <u>Authorization for Credit History</u>. The Customer or undersigned individual who is either the credit applicant or a principal/agent of the Customer, recognizes that a credit history report may be a factor in the evaluation of the credit history of the Customer. Customer, therefore, consents to and authorizes the use of a commercial, consumer or any other credit report on the Customer or undersigned individual by MBCI from time to time as may be needed in the credit evaluation process.
- 11. <u>Customer Responsible for Accuracy of Order/Delivery</u>. Customer hereby assumes responsibility for the accuracy of verbal orders unless written confirmation is received prior to fabrication. Confirming orders should be marked "Confirming Order- Do Not Duplicate." Customer may arrange for pickup of order at MBCI's plant or shipment will be made by common carrier "Freight Collect" unless other arrangements are previously made.
- 12. <u>Cancellation</u>. Either party may cancel this Agreement by giving written notice to the other party not less than seven (7) days prior to date of shipment of the Equipment; provided, however, that the Terms and Conditions provided herein shall apply and remain in full force and effect with respect to any and all transactions entered into by and between MBCI and Customer. In the event of such cancellation, Customer agrees to pay MBCI for any and all costs and damages occasioned by the can- cellation hereof.
- 13. <u>Condition of Equipment: No Warranties; Disclaimer</u>. It is agreed and understood that Customer has carefully inspected the Equipment and accepts the same in good condition and that Customer agrees that the Equipment is free from any defect and is properly and carefully assembled. Customer agrees that should any defect ever exist in Equipment, the Equipment will not be used until it is properly repaired, and Customer's sole and exclusive remedy shall be limited to, in MBCI's sole disc-cretion, the replacement of defective parts. F.O.B. MBCI's plant (transportation, redesign, dismantling, disposal of material and installation are not included), or repair of defective parts. The Eutomer shall be entitled to the foregoing remedy only if (i) the defect was not caused by Customer, (ii) the Customer notifies MBCI of the defect within five (5) days after delivery of the Equipment to Customer (which the Parties agrees is a reasonable time), and (iii) all amounts owing to MBCI under this or any other agreement with MBCI must be fully paid. Customer will not remover or damage any identifying marks on the Equipment (such as serial numbers, logos, name of MBCI as owner). MBCI HEREBY EXPRESS OF MARRANTIES, EXPRESS OF MIMPLIED, UNITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND THE PARTIES HERETO HERE- BY STIPULATE THAT ALL SUCH WARRANTIES ARE HEREBY DISCLAIMED.
- 14. Use, Repair and Maintenance. Customer agrees to at all times use, maintain and care for the Equipment properly and in compliance with all manufacturer's manuals and instructions and all applicable laws, to perform daily operational checks, to use it within its rated capacity, to restrict its use to Customer's qualified personnel and to prohibit anyone other than authorized personnel of MBCI to repair or adjust the Equipment except for routine maintenance, for which Customer shall be fully responsible and which shall be performed as specified in the Seamer Specification and Maintenance Section of the Field Seaming Tool Manual (which Customer acknowledges receiving). Customer agrees to accept full responsibility and liability for any and all damages to the Equipment due to improper operation and/or lubrication, freezing, fire, theft, windstorm, halostorm, flood, rich, insurrection, strike, explosion, collision, upset, damages while being transported, loaded or unloaded, or for any causes whatsoever other than ordinary wear and tear. Customer shall notify MBCI immediately of accidents, disabilities, failures or like information concerning the Equipment. Customer further agrees to pay for all damage to the Equipment upon receipt of invoices therefor from MBCI or the costs and expenses of repair. MBCI may inspect the Equipment at any time during normal business hours.
- 15. <u>No Incidental, Special or Consequential Damages</u>. Notwithstanding any other agreement to the contrary, Customer hereby agrees and stipulates that MBCI shall not be liable for any incidental, special, compensatory, expectation, exemplary or con-sequential damages, which Customer may suffer for any reason, including reasons attributable to MBCI. Customer further agrees that MBCI shall not be liable to Customer for failure to repair the Equipment if disabled or to furnish substitute Equipment for any reason whatsoever.
- 16. <u>Acceptance of Change Orders</u>. Customer may submit a written request for change orders to MBCI adding, deleting or altering the quantity or type of the Equipment ordered. MBCI, upon receipt of a written request for change order, shall price the requested changes and send to Customer a price quotation thereof. MBCI shall be under no obligation to accept or perform a request for change order unless Customer accepts in writing, without alteration or adjustment, the change order at the prices and terms quoted by MBCI.
- 17. Insurance. During the term of the lease of the Equipment covered by this agreement. Customer will, at its sole expense, procure and maintain in full force and effect liability insurance in amounts no less than \$1,000,000 per orplacement value (new) of the Equipment and shall name Customer as loss payee. Customer agrees to name MBCI as an additional named insured with respect to the coverages required by this agreement. Such property damage insurance shall provide coverage for the replacement value (new) of the Equipment and shall name Customer as loss payee. Customer agrees to name MBCI as an additional named insured with respect to the coverages required by this agreement and to provide MBCI with a conformed Additional Named Insured Endorsement setting forth the coverages required by this agreement. Customer agrees that its insurance coverages as required by this agreement shall be primary to and not concurrent with any insurance coverages maintained by MBCI and that any such coverages maintained by MBCI shall in no way be implicated unless and until all available coverages required by this agreement shall have been fully exhausted.
- 18. Force Majeure. MBCI shall not be liable to Customer for liquidated damages, back charges or loss of use to Customer arising out of any delay or any other reason in carrying out this Agreement. Under no circumstances shall MBCI be liable in any way to Customer, building owner or any other party for delays, failure in performance, or loss or damage due to force majeure conditions including, without limitation: fire; flood; epidemics; quarantine; lightening; strike; embar-go; explosion; power surge or failure; acts of God; war; labor or employment disputes; civil disturbances; acts of civil or military authority; inability to secure materials, fuel, products or transportation facilities; acts or omissions of sup- pilers; or any other causes beyond MBCI's reasonable control, whether or not similar to the foregoing.
- Jurisdiction/Venue/Maiver of Jury Trial. Customer hereby acknowledges, stipulates and agrees that (i) any and all claims, actions, proceedings or causes of action relating to the validity, performance, interpretation, and/ or enforcement hereof must be submitted to a court of competent jurisdiction in Houston, Harris County, Texas, (ii) to the maximum extent practicable, this Agreement will be deemed to call for performance, interpretation, and/ or enforcement hereof must be submitted to a court of competent jurisdiction in Houston, Harris County, Texas, (iii) customer irrevocably submits itself to the jurisdiction of the state and federal courts in Harris County, Texas, (iv) service of process may be made upon it in any legal proceeding in connection with this Agreement as provided by Texas alw, (v) Customer irrevocably waives, to the fullest extent permitted by law, any objection that it may now or hereafter have to the laying of venue of any litigation arising out of or in connection with this Agreement or any other agreement or transaction brought in any such court, (vi) Customer irrevocably waives any claims that litigation brought in any such court have to the laying of venue of any litigation arising out of or in connection with this Agreement or any other agreement or transaction brought in any such court, by the mailing of copies thereof by Certified Mail, Requested, posited any list address set forth herein. The scope of each of the foregoing waivers is intended to be all encompassing. Customer acknowledges NOT TO ELECT A TRIAL BY JURY OF ANY ISSUE TRIABLE OF RIGHT BY JURY. AND FULLY WAIVES ANY RIGHT TO TRIAL BY JURY TO THE EXTENT THAT ANY SUCH RIGHT NOW OR HEREAFTER EXISTS WITH RESPECT TO THIS AGREEMENT AND/OR THE AGREEMENTS, INSTRUMENTS AND DOCUMENTS CONTEMPLATED HEREBY OR ANY CLAIM, COUNTERCLAIM OR OTHER ACTION ARISING IN CONNECTION HEREWITH. EACH PARTY ACKNOWLEDGES AND AGREES THAT THIS WAIVER OF RIGHT TO TRIAL BY JURY WOULD OTHER WISE ACCRUE. EITHER PARTY IS HEREBY AUTHORIZED TO FILE
- Indemnification. CUSTOMER ASSUMES ENTIRE RESPONSIBILITY AND LIABILITY FOR ANY CLAIMS OR ACTIONS BASED ON OR ARISING OUT OF INJURIES, INCLUDING DEATH, TO PERSONS OR DAMAGES TO OR DESTRUCTION OF PROPERTY, SUSTAINED OR ALLEGED TO HAVE BEEN SUSTAINED IN CONNECTION WITH OR TO HAVE ARISEN OUT OF INJURIES, INCLUDING DEATH, TO PERSONS OR DAMAGES TO OR DESTRUCTION OF PROPERTY, SUSTAINED OR ALLEGED TO HAVE BEEN SUSTAINED IN CONNECTION WITH OR TO HAVE ARISEN OUT OF INJURIES, INCLUDING DEATH, TO PERSONS OR DAMAGES AND EMPLOYEES, INCLUDING CLAIMS OR ACTIONS FOUNDED IN THE PERFORMANCE, OR THE PERFORMANCE OF THIS CONTRACT BY CUSTOMER, ITS AGENTS AND EMPLOYEES, AND ITS SUBCONTRACTORS, THEIR AGENTS AND EMPLOYEES, INCLUDING CLAIMS OR ACTIONS FOUNDED IN WHO OR IN PART UPON THE ALLEGED ACTS, OMISSIONS OR NEGLIGENCE OF MBCI, MBCI'S REPRESENTATIVES, OR THE EMPLOYEES, ACENTS, INVITEES, OR LICENSEES THEREOF, CUSTOMER FURTHER AGREES TO DEFEND ANY CLAIM OR SUIT OR ACTION BROUGHT AGAINST MBCI, MBCI'S REPRESENTATIVE, AND THE EMPLOYEES, AND LICENSEES THEREOF IN RESPECT OF ANY SUCH MATTERS AND AGREES TO DEFEND ANY CLAIM OR SUIT OR ACTION BROUGHT AGAINST MBCI, MBCI'S REPRESENTATIVE, AND THE EMPLOYEES, AGENTS, INVITES AND LICENSEES THEREOF. THE PARTIES HEREBY WAIVE THEIR RESPECTIVE RIGHTS UNDER THE DECEPTIVE TRADE PRACTICES CONSUMER PROTECTION ACT, SECTIONS 17.41 THROUGH 17.63 INCLUSIVE, OF THE TXAS AND COMMERCE CODE, A LAW THAT GIVES CONSUMERS SPECIAL RIGHTS AND PROTECTIONS. AFTER CONSULTATION WITH LEGAL COUNSEL, EACH VOLUN-TARILY CONSENTS TO THIS WAIVER.
- 21. Severability. Each of the provisions of this Agreement is a separate and distinct agreement and independent of the others. If any provision of this Agreement is found to be invalid or unenforceable in any jurisdiction, such provision shall be fully severable in such jurisdiction, and this Agreement shall be construed and enforced as if in such jurisdiction such provision had never comprised a part hereof. In such event, the remaining provisions of this Agreement shall be to such jurisdiction and this Agreement shall be construed and enforced as if in such jurisdiction such provision had never comprised a part hereof. In such event, the remaining provisions of this Agreement shall remain in full force and effect. The terms of this Agreement are intended by the parties as a final expression of their agreement containing all oral and written understandings between the parties relative to the materials generally described in this Agreement.
- 22. <u>Acceptance/Entire Agreement</u>. As a condition precedent to the effectiveness of an order, all orders are subject to approval and acceptance by MBCI. This Agreement, along with any attached exhibits, constitutes the entire agreement of the parties herein.
